NOTICE FOR ADMISSION TO CLASS 1

1. The provisionally shortlisted candidates for admission to Class I (2020-201) will be published in the Vidyalaya Web Site./ Notice Board.on11.08.20 (9.00 pm) No personal intimation will be issued to candidates/parents on publishing/ updating provisional selection/ waiting list.
2. Only Parents to report for admissions as per schedule below without fail. Students may not be brought to school due to COVID 19 . **The Parents who are coming to school should follow The Covid 19 protocol**
3. Those who are shortlisted on the basis of any wrong certificate / declaration will be cancelled. **No appeal against such action will be entertained.**
4. Out stationed parent's cases normally may be rejected in categories under transferable Govt. Employees. Otherwise they have to submit a valid document for their claim in Pondicherry station.
5. The following documents should be produced in original at the time of admission.
 - **Print out of online application form and acknowledgement for registration.** One pass port size photo (taken within six months)to be pasted at relevant space.
 - Date of Birth Certificate along with an attested (attestation done by the parent only) copy. (The original Date of Birth Certificate will be returned after verification.)
 - Proof of residence from the competent authority. Those who are staying in Govt. accommodation to bring the quarter allotment order. All others to bring Following documents as proof of residence. **Ration Card/ Electricity Bill/Postpaid Phone Bills/ Documents on Gas connection / House tax Receipt / Aadhar Card/ Proof of Residence from the competent revenue authority.**
 - Caste certificate(SC/ST/OBC) in the **name of the child** where ever applicable. If the same could not be produced in the name of the child, an undertaking to be submitted in the effect that the same will be produced within 6 months from the date of admission. At the time admission at least valid caste certificate to be submitted in the name either one parent for taking claim on reserved admissions.,
 - **Original affidavit in case of Single Girl Child** (duly signed by Judicial I class Magistrate. (Wherever applicable)
 - EWS /BPL candidates to produce proof of such effect from the competent authority ie Tahsildar or above ranked officers.
 - JIPMER Employees/ Retired JIPMER Employees to bring proof of their Claim from the authorized person nominated / earmarked by the Director JIPMER& Chairman VMC for the said purpose.ie. Service Certificate to be signed by the designated officer,
 - Transfer details including the copies of transfer orders in case of Category II to V.
