- **2.** Offer of admission to the Candidates failing to provide supporting documents required for admission (as per information submitted in the appliaction) will stand cancelled and no appeal against such action will be entertained.
- **3.** The following documents should be produced in original (along with photo copy self-attested by parents) at the time of admission:
 - **a.** Date of birth certificate of Child.
 - **b.** Proof of residence from the competent authority. Those who are staying in government accommodation to bring staff-quarter allotment order. All others may bring any of the following as proof of residence:- Ration card/electricity bill/postpaid phone bills/document on gas connection/house tax receipt /proof of residence from the competent revenue authority.
 - **c.** Caste certificate (SC/ST/OBC NCL) in the name of child. OBC NCL certificate from the competent State/ UT authority as per the latest notification.
 - **d.** EWS/BPL candidates to produce proof of such claim from the competent authority i.e. Tahsildar or above ranked Revenue officers.
 - **e.** JIPMER employees to bring proof of service from the authorized person nominated /earmarked by the Director JIPMER and Chairman VMC for the said purpose i.e. Service certificate to be signed by designated officer. Photo copy of the JIPMER id card also to be submitted.
 - **f.** Transfer details including the transfer orders in case of service category II to V.
